# Consortium for Kraft lignin

Background:

- When Kraft lignin is separated from the black liquor and delivered as a product to a third party it is defined as a chemical substance.
- Kraft lignin is exempted from REACH registration since it is a natural polymer, but the CLP obligations and other requirements in REACH do apply.
  - REACH requires that a Safety Data Sheet is provided to the third party.
  - CLP requires that the substance is classified, labeled and packaged correctly. The legal entity must identify all relevant information publicly available about the hazards of the substance and evaluate its quality. Furthermore, the CLP regulation says that new information concerning physical hazards are always necessary to obtain but the entity is not obliged to generate new toxicological or eco-toxicological data for the purpose of classification.
  - CLP also requires, if the substance is classified as hazardous that a notification to the C&L inventory shall be done. The goal is that all companies that have made a C&L notification shall come to an agreement on the classification.
